MEMORANDUM OF UNDERSTANDING FOR ACADEMIC AND RESEARCH COOPERATION

Purpose:

The purpose of this Agreement is to promote cooperation in Education and Research

and

Adarsh Shikshan Sanstha's College of Pharmac, Beed

Types of Cooperation:

Through this memorandum, both Parties affirm the value of international collaboration and agree to promote the following activities:

1. Exchange of books and study material.
2. Exchange of periodicals and reference book.
3. Joint organization of programs like book exhibition.
4. Opportunities for Faculty & Students to avail laboratory and library facilities.
5. Faculty & Students exchange in various academic activities.

As mutually agreed

This Agreement places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

Principal, Dr. Suryakant Pandurang Dhonde will serve as the primary liaison between the two institutions to facilitate the development of future activities.

Terms:

This Agreement will become effective upon the date signature by both Parties. It shall remain valid for a period of five (5) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both parties. This Agreement may be terminated by either Party with advance written notice of at last thirty (30) days. Upon notice of termination

both NSSR'S College of Physical Education, Beed. agree to work in good faith to enable visiting scholars to complete their respective research programs unhindered by the termination. The agreement may be extended by mutual consent of the two parties after the five-year period and it must renewed in writing.

This Memorandum of Understanding completed is hereby signed in two (2) copies with one (1) copy remaining in the possession of each Institution.

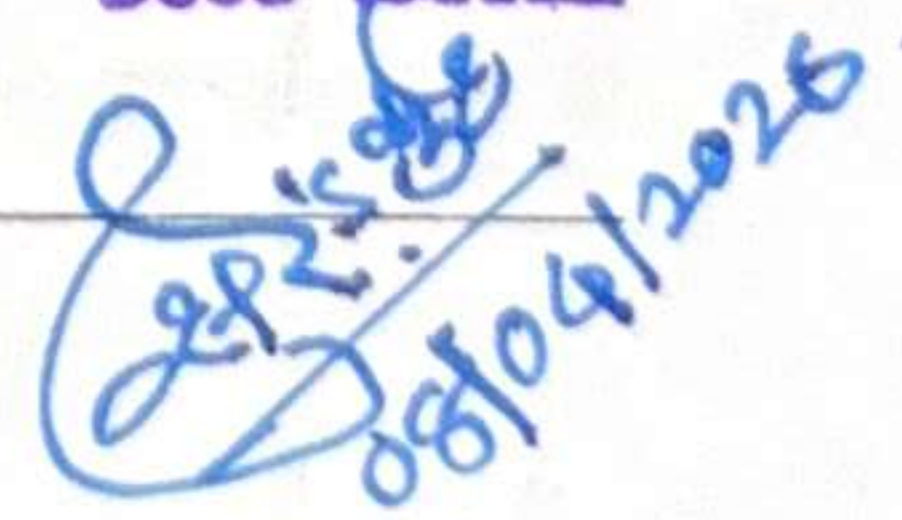
